Rating Rationale:

CRA identifies high structural, portfolio and credit risks and an increased operational risk. Macroeconomic forces such as high inflation and increasing interest rates and a changing office working environment dominate the office real estate market. The full depreciation of one loan in full at the end of last year and the modification of another loan which led to a significant write-down, resulted in a substantial negative credit enhancement. This credit impairment determines the results of the quantitative analysis, especially against the background that the portfolio consists of only 2 loans (incl. the last loan written-off). Based on the updated information and corresponding analysis CRA continues to see considerable challenges for the borrower to fulfil its obligations arising from the rating object in full. CRA confirms the rating of C.

Primary Key Rating Factors:

- (+) Possibility of early amortization payments to build up credit enhancement
- (+) Deferrable coupon
- (+) No currency risks within the structure
- (-) Default of one loan in December 2022 and write-down to 0 USD; default and restructuring of a second loan resulted in a partial write-down
- (-) Final fund size and number of portfolio asset significantly below originally CRA expectation
- (-) High structural, portfolio and credit risk
- (-) Low diversification of the portfolio
- (-) Soft investment criteria

Ratings Sensitivities:

CRA assumes in its best-case scenario a one-grade improvement of the collateral quality (via CRA's Property Grade assumption) of the portfolio loan and derives a rating result of C.

CRA assumes in its worst-case scenario a deterioration of the collateral quality (via CRA's Property Grade assumption) of the portfolio loan and derives a quantitative result of C.

ESG-Criteria:

CRA generally takes ESG-relevant factors (environmental, social and governance) into account when assessing the rating object. In the present case, ESG criteria had no comprehensive impact to the rating.
