Rating summary:

The portfolio financed by rated senior loan facility agreement suffered from a default of a seller NoCo2. This resulted in the decrease of the minimum reserve amount and increase in share of disputed receivables. Currently, we are estimating the impact of this change on the rating result. Based on this, CRA sets watch negative for this rating.

Primary key rating driver:

- Default of a seller with a higher concentration

- Reserve amount is below the minimum amount

Rating sensitivities:

Best-case scenario: In this scenario, we set the rating base case assumptions unchanged, resulting in a rating of BBB.

Worst-case scenario: In this scenario, we stressed (ceteris paribus) the seller default ratio increasing from 3.9% to 8.9%, resulting in a rating of CCC.

ESG-criteria:

CRA generally considers ESG factors (environment, social and governance) within its rating decisions. In the present case, ESG criteria had no comprehensive impact to the rating.

ESG factors with material impact were not identified.
