Rating Rationale:

CRA does not identify any adverse change in structural risk drivers compared to the assessment in the last rating action. While credit enhancement in the form of give back mechanism regarding fixed and variable interest payments has increased, the Compartment's liquidity reserve (DLR) has been reduced significantly. Overall, the market environment remains uncertain and operational risks are still elevated, especially in light of the global economic downturn and increasing interest and inflation rates. The investment period of the fund will end within the next six months. Therefore, blind pool risks are still existent, but only to a very limited extent. CRA identifies moderate portfolio and credit risk and thus does not note any material changes compared to the previous year. Based on the quantitative results and taking into account qualitative factors, in particular the increased uncertainty of the future performance and creditworthiness of the portfolio companies against the backdrop of current economic developments, Creditreform Rating confirms the rating of BBB/stable.

Primary Key Rating Factors:

- (+) Credit enhancement through give back of interest payments in a shortfall event and principal deficiency ledger mechanism
- (+) Expected security packages at underlying loans level
- (+) Solid track-record of the asset manager (careful selection of loans, current deal flow)
- (+) Hedging of FX-risks on amortization payments coming from the underlying loans (but no/marginal hedging of interest payments)
- (+) Increased reference rates (Euribor, Libor) lead to higher cash inflows, which have not been covered in the quantitative analysis
- (-) Overall sub-investment grade asset quality
- (-) Possible leverage at fund level and possibility to pledge fund's assets in favour of other creditors
- (-) Exit / refinancing risks
- (-) Risks from the current economic downturn and increased interest charges for target companies of private debt funds

Ratings Sensitivities:

Best-case scenario: In this scenario, we stressed (ceteris paribus) PDs of the portfolio assets and cash yields for every loan type by an amount of +1 notch and +100 bps respectively, resulting in a rating of BBB+.

Worst-case scenario: In this scenario, we stressed (ceteris paribus) PDs of the portfolio assets and cash yields for every loan type by an amount of -1 notch and -100 bps respectively, resulting in a rating of BB.

ESG-Criteria:

CRA generally considers ESG factors (environment, social and governance) within its rating decisions. In the present case, ESG criteria had no comprehensive impact to the rating.

ESG factors with material impact were not identified.

Regulatory Requirements and Legal Disclosures :

Creditreform Rating AG was mandated on 22/06/2018 by Ardian Investment Solutions S.A. to conduct a rating for the bearer notes under Luxembourg law, issued by Ardian Investment Solutions S.A., acting in respect of its compartment AIS-APDIV-C6 (Borrower). This is a public rating which is regulatory applicable according to EU Regulation 1060/2009 (CRA-Regulation).

The rating was conducted on the basis of Creditreform Rating's "Issue Ratings" and "Technical Documentation - Portfolio Loss Distribution" in conjunction with Creditreform's basic document "Rating Criteria and Definitions".

Important sources of information in the context of the rating were, in addition to the submitted documents, regular e-mail exchanges. The submitted documents and information provided by Ardian group or rather the Issuer were sufficient to meet the requirements of Creditreform Rating AG's rating methodology.

This rating was carried out by analysts Lars Köhler (Lead), Jan Löckenhoff and Qinghang Lin, all located in Neuss/Germany. The function of Person Approving Credit Ratings (PAC) was performed by Sascha Pomorin.

Closing of the transaction occurred on 13/07/2018. The rating is based on the portfolio information and transaction documentation as of 21/04/2023, as provided by Ardian group or the Issuer.

The issuer or all relevant parties have examined the rating report prior to publication and were provided with at least one full working day to appeal the rating committee decision and provide additional information. The rating decision was not amended following this examination.

Ancillary services were provided. A pre-rating was conducted.

1. Transaction structure and participants
2. Transaction documents
3. Issuance documents

There are no other attributes and limitations of the credit rating or rating outlook other than those displayed on the CRA website. Furthermore CRA considers satisfactory the quality and extent of information available on the rated entity. In regard to the rated entity Creditreform Rating AG regarded available historical data as sufficient.

Between the time of disclosure of the credit rating to the rated entity and the public disclosure, no amendments were made to the credit rating.

This rating was not endorsed by Creditreform Rating AG from a third country as defined in Article 4 (3) of the CRA-Regulation.
